- Connelly Home celebrated it's 25th Anniversary with a Mass at St. Therese the Little Flower and an Open House at Connelly. Over 100 old and new friends gathered to celebrate. Young Neighbors in Action is a national, service-learning program that provides older youth and adults from Catholic parishes and schools the opportunity to receive an integrated services learning experience. HISTORY AND SERVICES



Catholic Residential Services was established in 1992 by the Archdiocese of Cincinnati in response to the requests of Catholic families in need of services for their adult children with mental retardation. At that time, two group homes already offering services with Catholic affiliation, the former Villa Maria and Connelly Home, were incorporated under the newly formed Catholic Residential Services. Today, we continue to serve the individuals of those homes and have expanded services to others in need. We have strengthened our commitment to residential services by focusing on smaller living arrangements, increased individualized care, and providing services to those with physical disabilities.

Under the guidance of the Board of Trustees, Catholic Residential Services has more than doubled our staff, the number of individuals serviced, the locations we provide services in, and even office space over the last nine years. Our agency currently assists 38 clients to achieve their life goals in 19 different locations.

Catholic Residential Services continues to balance growth with staying true to our roots - meeting the individual needs of each client through and with faith, spirit, friendship, acceptance, and independence. We will continue to consistently provide services where individuals can reach their fullest measure of personal development while building community within each home, each neighborhood.

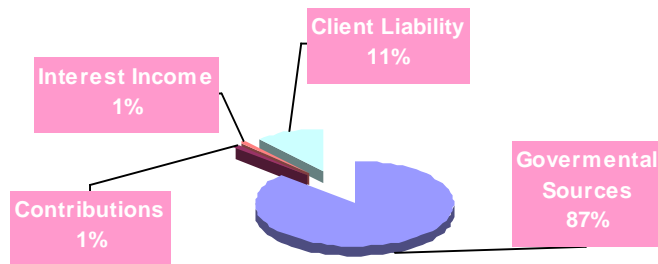
CATHOLIC RESIDENTIAL SERVICES FINANCIAL STEWARDSHIP



Catholic Residential Services is a non profit agency that appreciates the funding we receive from federal, state and county sources. Throughout the organization, we attempt to stretch the dollars that we receive as much as possible.

Catholic Residential Services fiscal year is from June to July of each year. A independent audit is completed for each fiscal year. During the fiscal year of 2004/2005, Catholic Residential Services total income was \$1,846,100, total expenses - \$1,884,009 and the ending net asset was \$555,654.
